- A. Scott Schuster called the meeting to order at 4:03 pm.
- B. East Hampton – Presented the Executive Board with an option to place schools based on geography.
- C. Internal Claims Auditor
 - The March and April 2021 Internal Claims Auditor report was reviewed by the Executive Board.
 - The Board reviewed the Internal Claims Auditor Duties along his proposal for 2021-22 with an increase from \$52 per hour to \$54. Approved
