B. ADMINISTRATIVE TASKS

1. Develop and distribute schedules.

2. Assign officials.

3. Monitor and control officials' rating system.

4. Pay officials

5. Bill schools for officials' services, dues, service charges, miscellaneous fees and charges.

6. File 1099 and W2 forms with IRS.

7. Maintain financial records.

8. Monitor and maintain records for the fingerprinting of all officials.

9. Hire, train, and supervise office staff.

10. Assign and monitor Sport Chairmen.
11. Facilitate Section Tournament Events - tickets, awards, admissions, officials, sites, facility rental, media coverage, etc.
12. Develop an annual budget (\$1,700,000+) and approve all expenditures.
13. Monitor, enforce, and interpret rules, regulations, and policies.
14. Attend to contractual matters (officials) and all payments to officials (over \$3 million).
15. Supervise misconduct policy and procedures.
16. Oversee sportsmanship program.
17. Prepare publications - directory, atlas, sport chair manual, etc.
18. Receive and forward all correspondence for the Section.
19. Arrange travel to Regional & State competition (rooms, transportation, and meal stipends).
20. Organize various Section functions - new athletic directors' workshops, secretarial workshops, safety and "Life of an Athlete" conferences, meetings of all committees, Athletic Council/Conferences, etc.
21. Arrange for insurance coverage (liability and business).
22. Facilitate all meetings, protests, appeals, hearings, etc. relative to interscholastic athletics.
23. Supervise Section Office – accounting, equipment, maintenance, supplies, insurance, payroll, etc.
24. Prepare agendas for and maintain records of all meetings.
25. Arbitrate disputes between member schools when necessary.
26. Act as a resource for member schools on various matters pertaining to interscholastic athletics.
27. Maintain records of contest statistics for purpose of seeding Section Tournaments and determining league/division rankings.
28. Maintain all aspects of the Section XI website, [www.sectionxi.org](http://www.sectionxi.org)
29. Coordinate and implement DASA and Coaching Certification training site.
30. Develop alternative funding streams, i.e., corporate sponsorship.
